

**Prison Rape Elimination Act
2025 PREA Coordinator's Annual Report**



This report has been prepared in accordance with §115.87 and §115.88 of the PREA Standards to address and improve the effectiveness of the McHenry County Adult Correctional Facility in sexual abuse prevention, detection, and response policies, practices, and training. In subsequent years, the information collected for this report will be used to identify problem areas and to take corrective action on an ongoing basis.

Prison Rape Elimination Act (PREA)

The Prison Rape Elimination Act (PREA) is a federal law that prohibits sexual misconduct in correctional settings such as prisons, jails, lockups, juvenile facilities, and Immigration Services/ICE detention facilities.

The McHenry County Sheriff's Office is committed to enforcing a zero-tolerance policy for sexual abuse or assault of inmates, either by staff or inmates. It shall be the policy of the McHenry County Sheriff's Office Corrections Division to provide a safe and secure environment for all inmates, employees, contractors, and volunteers free from the threat of sexual abuse or assault by maintaining a *Sexual Abuse and Assault Prevention and Intervention Program* that ensures effective procedures for preventing, reporting, responding to, investigating, and tracking incidents or allegations of sexual abuse or assault. The Corrections Division shall conduct investigations in a manner that avoids unnecessary embarrassment or indignity to the inmate. It shall also be the policy of the McHenry County Sheriff's Office to pursue administrative, disciplinary, and/or criminal sanctions against any inmate, staff member, contractor, or volunteer found to have committed sexual abuse or assault against an inmate. It shall be the responsibility of the medical staff to provide immediate first aid to the victim and to refer the inmate to the appropriate medical facility.

General Information

During 2016, there were 6,610 new admissions into the McHenry County Adult Correctional Facility. Of the new admissions, 5,515 were male and 1,095 were female. The average daily population was 440 (398 males and 42 females).

During 2017, there were 6,615 new admissions into the McHenry County Adult Correctional Facility. Of the new admissions, 5,405 were male and 1,210 were female. The average daily population was 472 (416 males and 56 females). ****Note**** There were two numerical errors made this year that caused the numbers between the reported and actual numbers to be off.

During 2018, there were 6,844 new admissions into the McHenry County Adult Correctional Facility. Of the new admissions, 5,603 were male and 1,241 were female. The average daily population was 510 (441 males and 69 females).

During 2019, there were 6,452 new admissions into the McHenry County Adult Correctional Facility. Of the new admissions, 5,200 were male and 1,252 were female. The average daily population was 503 (436 males and 67 females). We have a new category for 2019: "non-reportable." The auditor who completed our last audit informed the Corrections Division that we were reporting too much information, so the non-reportable category was created.

During 2020, there were 3,980 new admissions into the McHenry County Adult Correctional Facility. Of the new admissions, 3,312 were male and 668 were female. The average daily population was 372 (333 males and 39 females).

During 2021, there were 3407 new admissions into the McHenry County Adult Correctional Facility. Of the new admissions, 2,764 were male and 643 were female. The average daily population was 338 (301 males and 37 females). In 2021, there were two substantiated staff instances of sexual harassment. 1 was contract staff, and 1 was custody staff. Both staff members are no longer employed at this facility.

During 2022, there were 2974 new admissions into the McHenry County Adult Correctional Facility. Of the new admissions, 2,297 were male and 677 were female. The average daily population was 221 (194 males and 27 females).

During 2023, there were 3,073 new admissions into the McHenry County Adult Correctional Facility. Of the new admissions, 2,371 were male and 702 were female. The average daily population was 216 (191 males and 25 females).

During 2024, there were 3,728 new admissions into the McHenry County Adult Correctional Facility. Of the new admissions, 2,980 were male and 748 were female. The average daily population was 373 (350 males and 23 females.)

During 2025, there were 3,674 new admissions into the McHenry County Adult Correctional Facility. Of the new admissions, 2,923 were male and 751 were female. The average daily population was 325 (305 males and 20 females.) We are removing the "non-reportable" category for 2026. We will use "unfounded" for any fabricated, fictional, or untrue allegations. An incident that happened in another facility will be reported to that facility and logged under the "other facility" category with no time limit for reporting.

Findings Definitions

Substantiated: The allegation was investigated, and the investigation indicated that the alleged event did occur.

Unsubstantiated: The allegation was investigated, but there is insufficient evidence to determine whether or not an event occurred.

Unfounded: Allegations were investigated, and the investigation indicated the alleged event did not occur.

Non-PREA: The allegation was investigated, and the investigation revealed that a PREA-alleged event did not take place.

Ongoing: The investigation is ongoing.

Other Facility: An incident occurred outside of McHenry County.

Out of Country: Any allegations or incidents reported by detainees or inmates that occurred in a country other than the USA

Non-Reportable: The allegation was investigated, and the investigation indicated that the allegation was fabricated, fictional, or untrue, or an incident that happened in another facility at least six (6) months prior to being reported by the detainee or inmate.

Incident Reviews at PREA

The McHenry County Adult Correctional Facility has implemented a Sexual Abuse Incident Review Group per PREA Standard 115.86. Under this standard, the Corrections Division must conduct a sexual abuse incident review at the conclusion of every sexual abuse investigation, including where the allegation has not been substantiated, unless the allegation has been determined to be unfounded. Such a review will ordinarily occur within thirty (30) days of the conclusion of the investigation. The review team will include upper-level management officials with input from line supervisors, investigators, and medical or mental health practitioners. The Corrections Division will either implement the recommendations for improvement or document its reasons for not doing so.

Review Criteria:

1. Consider whether the allegation or investigation indicates a need to change policy or practice to better prevent, detect, or respond to sexual abuse.
2. Consider whether the alleged incident was motivated by race, ethnicity, gender identity, lesbian, gay, bisexual, transgender, or intersex identification, status, or perceived status; or gang affiliation; or was motivated by or otherwise caused by other group dynamics at the facility.
3. Examine the area in the facility where the allegation occurred to assess whether physical barriers in the area may enable abuse.
4. Assess the adequacy of staffing levels in that area during different shifts.
5. Assess whether monitoring technology should be deployed or augmented to supplement supervision by staff and
6. Prepare a report of its findings, including but not necessarily limited to determinations made pursuant to paragraphs (d)(1) through (d)(5) of this section and any recommendations for improvement, and submit such a report to the facility head.

Analysis: There were four (4) substantiated incidents of inmate-on-inmate sexual harassment. There were zero (0) incidents of staff-on-inmate sexual harassment and inmate-on-inmate or staff-on-inmate sexual abuse.

Corrective Action: None of the incidents required facility corrective action to be taken. The 4 substantiated incidents were investigated administratively. Three (3) out of the four (4) incidents were followed up with facility disciplinary action. Because the substantiated incidents were of a sexual harassment nature, there was no reason for evidence to be collected or inmate transfer to the hospital for forensic examination. One (1) of the incidents was referred to the Criminal Investigation Division but was not referred for criminal prosecution because the victim refused to pursue charges. Facility discipline was not recommended due to the inmate abusers' mental health status.

Training: We are dedicated to giving initial and annual refresher training to all staff and the inmates receive information on our zero-tolerance policy, what constitutes a PREA violation and how to report a PREA allegation.
